Expenditure Guide**

The range of standard rates of care is determined by the intensity of student needs supported by documentation in each application and is not based solely on the maximum allowable expenditures. Standard rates may vary; however, effort should be made to keep total expenditure for each service, per application, within the maximum allowable amount.
