Instructions for Entering Data for State Performance Plan Indicator 14

Indicator 14: Post-School Outcomes

Percent of youth who are no longer in secondary school, had IEPs in effect at the time they left school, and were:

- A. Enrolled in higher education within one year of leaving high school.
- B. Enrolled in higher education or competitively employed within one year of leaving high school.
- C. Enrolled in higher education or in some other postsecondary education or training program; or competitively employed or in some other employment within one year of leaving high school.

Authorization: 20 U.S.C. 1416 (a)(3)(B)

Due Date: **August 31, 2011**

Sampling Allowed: Yes

General Instructions

1. The 2010-2011 data collection period is **July 1, 2010** to **June 30, 2011**.
2. Indicator 14 refers to the students with disabilities who are currently enrolled in Grade 12 and are anticipated to exit through graduation at the end of the 2010-11 school year, and students with disabilities who have dropped out, completed a GED or graduated early since being reported as enrolled on the Fall 2010 Snapshot date.
3. Districts will generate a list of students with disabilities from all campuses that meet the **Criteria for Data Collection**. Once the 2010-2011 list of students is generated, place the names in alphabetical order.
4. This now becomes the official list and districts will follow the **Required Sampling Procedures**.
5. Enter the student's SSN or alternate student ID. The student's name and DOB will appear and pre-fill. Complete remaining fields.
6. Complete the Student Contact Information and Parent Contact Information sections. All (*) fields are required and must be completed. Additional Contact Information is optional, but recommended.
7. Complete the Graduation Information. Select the manner in which the student will exit high school. Select **ONE**. Complete the Post-School Goals by selecting **all** post-school goals included in student's IEP.

Specific Instructions

Data Entry- Indicator 14: Post School Outcomes

STEPS TO ADD A NEW STUDENT RECORD

1. Click on the **Data Entry** button in the navigation toolbar. The **Indicator 14: Exit Survey** will display.
2. Select the appropriate School Year, District, and Campus from the drop-down lists and then click on the **GO** button. The current year is the default school year. The ability to select Districts and Campuses is based on your user role.
3. Scroll to the Student Demographics: PET section in the middle of the screen and enter the student's SSN/Alt ID in the SSN/Alt ID field, then click on the **PET Match** button. The student record is highlighted automatically after a PET Match is found.
4. System will allow student data entry only after a **PET MATCH** is made.
5. **IF NO MATCH IS FOUND:**
 - **Check to be sure you have entered the SSN/Alt ID correctly.**
 - **Check to be sure the student is currently enrolled on campus.**
 - **Check with your PEIMS Coordinator to be sure you have the correct SSN/Alt ID.**
6. When the system has found a matching record from the PET database, the student record is highlighted automatically. Once the student's name is highlighted, the user may click the **Select Student** button.
7. The system will fill in the student's first name, last name, and date of birth.
8. Select the student's Grade Level from the drop-down list.
9. Select the student's Primary Disability from the drop-down list.
10. Select the appropriate answer for the Multiple Disabilities question.
11. Select the student's current Instructional Setting from the drop-down menu. Refer to the Help document for the list of instructional settings.

Note: A student's Entry record can be saved with a status of **Incomplete** as long as the following fields are complete: SSN, First Name, Last Name, DOB, Grade Level, Primary Disability, Multiple Disabilities, Instructional Setting and Date Services Began.
12. Scroll down to the next section of the screen **Student Contact Information** and select whether student address is USA or Outside USA. Enter required (*) information including: First and Last Name, Street Address, City, State, Country, and Phone Number. USA is the default.
13. Complete the **Parent/Guardian** section. Select whether student address is USA or Outside USA. Enter required (*) information including: First and Last Name, Street Address, City, State, Country, and Phone Number. USA is the default.
14. **Additional Contact Information** is optional, but recommended.
15. Complete the Graduation information by selecting the **manner in which the student will exit high school**. Select **ONE** option.
16. Select all post school goals in the student's IEP. This completes the data entry.

NO STUDENT DATA TO SUBMIT:

If you have **NO** data to submit for the current school year, then follow the steps below:

1. Click on the **Data Entry** tab on the navigation toolbar at the top of the screen.
2. Select the district and appropriate campus using the drop-down list and then click on the **Go** button. Campus detail information is displayed, including the nine digit campus number.
3. Scroll down the page to click the following link: [Click here if you have no student data to submit.](#)
4. The user will be directed to the Campus Administration page.
5. Scroll to the bottom of the screen to **review and check the assurance statements** and then click on the **Submit** button. The campus status changes from **Not Submitted** to **Submitted** and is now transferred to the District Certifier screen.
6. Notify district certifier that campus data has been submitted.

Campus Administration

STEPS TO SUBMIT CAMPUS RECORDS

1. Click on the **Campus Admin** button in the navigation toolbar.
2. Select the appropriate School Year, District, and Campus from the drop-down lists and then click on the **GO** button. The current year is the default school year. The ability to select Districts and Campuses is based on your user role.
3. Scroll down the page to student list. Check each student record to confirm it is accurate. If corrections need to be made, the option to delete or edit the student is available. Print the list and maintain the record.
4. Scroll to the bottom of the screen to [Submit Campus Data](#) **review** and **check** the assurance statements and then click on the **Submit** button. The campus status changes from **Not Submitted** to **Submitted** and is now transferred to the District Certifier screen.
5. Notify district certifier that campus data has been submitted.

District Administration

STEPS TO CERTIFY CAMPUS RECORDS:

1. Click on the District Home button from the menu at the top of any screen to access the District Administration screen.
2. The name of the assigned District will be displayed in the **Search District** field. Click the **Go** button and the system will display specific District information.
3. A list of submitted campuses is displayed at the bottom of the screen. To see detailed information for a campus, click on the campus name.

4. Click on the **Accept** button for each campus that is complete.
5. If a campus's status is incomplete the District Certifier must notify the campus with the incomplete status to inform them of their responsibility to complete the records and submit.
6. The **Certify** button will not be activated until all campus records have been **Submitted** and **Accepted**.
7. Verify that all campuses have been **Submitted. Read** and **Check** the assurance statements and then click on the **Certify** button to submit the data to TEA.
8. The Current Status at the top of the page will indicate **Certified**.

STEPS TO REQUEST DATA TO BE RETURNED:

District Data

1. Once the district has **Certified**, the District Certifier can request TEA to return data for corrections or additions by accessing the **District Admin** tab.
2. Select the appropriate school year and district. Click **Go**.
3. An email will be generated to TEA. Once TEA returns the data, the status will change to **TEA Returned**.
4. The District Certifier notifies the Data Entry Agent and returns the campus level data through the Campus Return Process.

Campus Return Process

1. From the **District Admin** page select a campus by clicking the button next to the campus number.
2. Select **Return Reason** button from the drop-down menu. A **Return** notes box will appear above the campus list. (The return text box will only allow 150 characters.) Enter return notes and then click on the **Return** button again. The campus status will change to **LEA Returned**.
3. Notify Data Entry agent that the campus data has been returned. Once the status has changed from **Submitted** to **LEA Returned**, the Data Entry agent may add, delete and/or correct student level data.
4. The Data Entry agent will need to resubmit the campus data.

Certifying TEA Returned District Data

1. Verify all campuses are in **Submitted** status.
2. Read and check the assurance statements.
3. Click **Certify**.
4. The Status will change from **TEA Returned** to **Certified**.
